TERMS AND CONDITIONS

Membership to the Paul Hopwood Consulting Senior Management Network 2 will only commence once this agreement is signed and received by MINDSHOP together with payment of the up-front joining fee and the first Monthly Investment.

Monthly Investments are payable on the 1st of each calendar month. Fees unpaid for 30 days may mean membership suspension. Members with fees unpaid beyond 60 days may have their membership terminated at any time with immediate effect upon written notice.

MINDSHOP Materials:

MINDSHOP is the owner of all intellectual property in the materials it provides to Members. Those materials may only be used by Members for their own purposes and for the purpose of training their staff in, and consulting to clients using, the MINDSHOP tools and processes (“permitted use”). Members are allowed to make and distribute copies of a reasonable portion of the MINDSHOP materials to their staff for the permitted use. Members are not allowed to make copies or distribute MINDSHOP materials to any person for any reason other than the permitted use or to make or distribute excessive copies of the MINDSHOP materials for the permitted use. Members are not permitted to make excessive amounts of the MINDSHOP materials generally available to all their staff. For the avoidance of doubt, the permitted use does not include any use that is in direct competition with MINDSHOP, such as training non-staff members in the MINDSHOP tools and processes.

Confidentiality:

During Paul Hopwood Consulting Senior Management Network 2 meetings, confidential matters may be discussed. Members are not, under any circumstances, to discuss these matters outside of the Paul Hopwood Consulting Senior Management Network 2 forum.

Professional Standards:

Members must behave in an ethical and professional manner whilst a member of the Paul Hopwood Consulting Senior Management Network 2.

Resignation and Termination of Membership:

Members must give the Chairman three months written notice of their intention to resign. The Monthly Investment continues to be payable in full on the 1st of each calendar month during this three month notice period. The Chairman may terminate a member’s membership at any time with immediate effect upon written notice. If the Chairman terminates a member’s membership for any reason, other than for breach of these terms and conditions, the Member will be reimbursed for the remainder of that month’s Monthly Investment.

Change of Employer:

If a Member leaves the employment of their organization, the continuation of the membership of the Paul Hopwood Consulting Senior Management Network 2 will be reviewed. If the member is moving to a position in competition with the previous employer, and that employer does not wish for the member to retain their membership, the matter shall be referred to the Chairman for resolution on a case by case basis.

Liability:

To the extent permitted by law, neither the Chairman nor MINDSHOP is liable to a Member for any loss or damage sustained by reason of the use of information and materials provided by the Chairman or MINDSHOP to the member. In any event, to the extent permitted by law, the liability of both the Chairman and MINDSHOP to a member is limited in total to the sum of all moneys actually paid by that member to either the Chairman or MINDSHOP under the terms of this agreement.

Updating Agreement:

These terms and conditions may be amended by MINDSHOP at any time provided that MINDSHOP will give all members three months notice in writing before doing so.
